V. CONDITIONS OF UNDER-GRADUATE & GRADUATE MEMBERSHIP

1. 2 passport-sized photographs of applicant and must accompany all application.
2. 1 photo-copy of passport or Identity Card of the applicant must accompany all application.
3. A single status applicant have no right to nominate in writing one partner to incorporate under their membership.
4. Under-Graduate – a letter of reference is required from the University.
(*Undergraduate*: referring to student that completed their high school and pursuing their bachelor/first degree in University only).
5. Graduate – a graduation certificate is required from applicant for verification.
(*Graduate*: Anyone who has completed their degree or Masters course and has moved into full time employment or is looking for work. This membership not available to those who are already employed and have returned to higher education to complete their Masters after a break from formal education).
6. **Employment Verification Letter** is required for SSB/SSPC/Petronas/PCSB employees
7. Proposer and Secunder must be (Full or Associate) members of the Club.
8. All outstanding payments to the Club must be settled on a monthly basis (Reference Article 4.5 of the Piasau Boat Club Constitution).
9. All cheque payments are to be made payable to the **Piasau Boat Club** only.
10. Applicant is required to **REGISTER** for **E-STATEMENT** via e-mail to pbcebill@piasaubaatclub.com and **stating your membership number**. Applicant not opting for the E-Statement, will still get their usual Club statement by normal mail and will be charged an administrative fee of RM10.60 nett per statement/month.
11. Applicant is also required to complete/sign the “**Piasau Boat Club Sports Waiver Form**” and returned to Club office together with Membership Form.
12. All information provided by the applicants will be kept confidential.
13. The minimum duration of membership is 6 months.
14. Any member resigning from the Club must tender a written one month notice to the Secretary of the Club.
