## VI. CONDITIONS OF MEMBERSHIP

1. 1 passport sized photograph & 1 photo-copy passport or Identity Card of both the applicant and spouse must accompany all applications.
2. Applicant is required to complete /sign the **“Registration cum Mandate Form For Authorization of Manual Charge Through Credit Card”** and attach photo-copy of applicant valid credit card. Please read the terms & condition of Credit Card attached behind before completing this form.
3. All outstanding payments to the Club must be settled on a monthly basis (Reference Article 4.5 of the Piasau Boat Club Miri Sarawak Constitution).
4. All cheque payments are to be made payable to the **Piasau Boat Club Miri Sarawak** only.
5. Applicant is required to **REGISTER for E-STATEMENT** via e-mail to [ebillpbc@piasauboatclub.com](mailto:ebillpbc@piasauboatclub.com) and **stating your membership number**. Applicant not opting for the E-Statement, will still get hardcopy of their Club statement by normal mail and will be charged an administrative fee of RM10.60 nett per statement/month.
6. All information provided by the applicants will be kept confidential.
7. Proposer and Seconder must be (Full or Associate) Members of the Club.
8. The PBC Committee reserves the right to request a refundable deposit from Full Member (amount of deposit to be decided by the PBC committee) in the event that the member has a record of slow payment in settling Club accounts.
9. **Employment Verification Letter** is required for SSB/SSPC/Petronas/PCSB employees.
10. A refundable deposit of RM1000.00 shall be payable by ALL Associate, Country Associate & Senior Citizen members at the time of application to join the Club.
11. Members on Temporary transfer out of town can apply to convert their membership to Country for the duration they are out of the area. They will be reinstated to their original membership status upon return to the area. Working on shifts (offshore/onshore) does not make one eligible for Country Membership.

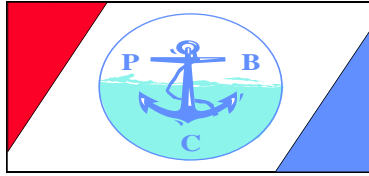

## TERMS & CONDITIONS OF CREDIT CARD

1. By opting for the Credit Card facility/facilities, the Member elects to make the payment of outstanding account to Piasau Boat Club Miri Sarawak (here after refer as PBC) from the Credit Card Holder's Bank Account through any authorized service provider that the Company may tie up with from time to time.
2. The Member agrees to abide by the terms & conditions of the Credit Card facility of Credit Card Issuer.
3. Payment by Credit Card shall not be effected for monthly payment.
4. The member agrees that he/she shall remain liable for all the instructions and transactions that have been submitted by him/her or processed under his/her account prior to the date of membership application obtaining PBC acknowledgment to the said Notice.
5. Any outstanding account prior to 60days from the date of providing information relating to the particulars of the credit card to PBC by the member should be paid by the member through the normal mode of collection (cash/Cheque/online 3<sup>rd</sup> party transfer).
6. The Credit Card Account shall be debited anytime after member fail to settle their outstanding account for more than 60days.
7. No reminder notices shall be sent during the term of Credit Card.
8. The records of PBC and / or its authorized Service Provider, on the outstanding account (more than 60 days) payments, maintained through computer systems or otherwise, shall be accepted as conclusive and binding for all purposes and shall be conclusive proof of the genuineness and accuracy of the same and binding for all purposes and can be used as evidence in any proceedings.
9. The member acknowledges that he/she is eligible to avail the facilities and agrees to provide true, accurate, correct and complete information as required by

- PBC and to keep the same updated and current at all times. Incorrect, incomplete, ambiguous forms will not be accepted and his/her membership will be subjected to be classified suspense until all outstanding account is settled.

  11. The member agrees that in addition payment of all outstanding account amounts, an additional bank charges is also applicable per transaction.
